

## Publishing agreement for electronic publication of book/working paper/pre-print via LiU E-Press

This agreement between the Author, identified below (in relevant cases, the term Author can refer to a collective of authors), and Linköping University via Linköping University Electronic Press (LiU E-Press) regulates the publication of the work identified below (and henceforth referred to as the Book, Working paper, Pre-print or, collectively, the Work). By signing the agreement, the Author agrees to the <u>Terms of publication when publishing electronically via LiU E-Press (Dnr: UB-2021-00042)</u> (henceforth referred to as Terms of publication). LiU authors can via LiU E-Press e-publish a Work according to the definition in the Terms of publication. This includes the following publication types (choose one):

- ☐ Creative Commons Attribution Non-Commercial (CC BY-NC) lets others read, distribute, adapt, and build upon the work non-commercially, as long as they credit the Author of the original creation.
- □ **No Creative Commons license.** (If you do not select any option, this option will be chosen by default.) With no explicit license, others will be able to read the work.

## Liability

Beyond the responsibilities stipulated in the <u>Terms of publication</u>, LiU E-Press will:

- Assign identifiers (such as ISBN and DOI) to the Work.
- If the Work is a Book printed by LiU's printing office LiU Tryck, offer readers the option to order the Book from LiU Tryck in print format via the Print-on-Demand service on a cost-price basis. <u>Read more</u>.

- Accepts the agreement and <u>Terms of publication</u>, including fulfilling accessibility requirements. <u>Read</u> more (Swedish)
- Certifies that the <u>Review form</u> for the Work has been completed
- In cases where the Work is a Book that has previously been published by another publisher, pledges to submit a certificate that permits e-publication via LiU E-Press (the certificate can for example state that the Author has regained copyright from the publisher, or that the publisher allows the Author to republish the Book). Read more about re-issuing a Book,
- Certifies that the identifiers of the publication (e.g. series, number in series, ISBN, DOI and ISSN) and the chosen Creative Commons license (if applicable) is displayed on the publication page in the Work, Read more
- Assigns LiU E-Press a non-exclusive right to e-publish the Work online via LiU E-Press with the Creative Commons license chosen by the Author (if applicable).

## **Publishing a Working Paper in a series**

If a Working Paper is to be published in one of LiU's series, deliver this agreement to the editor of the series for publication approval and assignment of a number in the series. If the Work is not included in a series, send the agreement directly to LiU E-Press.

## **Author signature**

If the Work has multiple authors, all authors need to sign the agreement. If the number of authors is more than four, the remaining authors sign a separate paper or on the back of the agreement.

If the Work is an anthology (Book or Working Paper), this agreement is signed by all the editors of the anthology. With the agreement, attach a document where all chapter authors consent to e-publication with the chosen license.
